

## AgLink celebrates 2025

More than 100 valued partner suppliers alongside 15 representatives from AgLink International membership, including colleagues from AgLink Canada, Novafield in Europe, and ICD in New Zealand were in the room.

CEO **Ian Scutt** said AgLink places immense value on their network.

### AgLink Australia is currently:

- 13 member businesses strong, employing over 1770 staff, including 300 agronomists, across 233 retail locations nationwide
- group revenue has grown to \$2.4 billion, up from \$2.25 billion in 2024
- members have collectively contributed nearly \$1.2 million to community support programs across Australia over the past year.
